



Tredyffrin Township Public Access TV

Annual Sponsored-Producer Statement of Compliance Form

- A. I have read and understand the Tredyffrin Township Public Access TV Rules and Procedures Manual available in the Greenwood Studio or online at www.tredyffrin.org/general/cable/publicaccess/documents.aspx . I am thoroughly familiar with the rules, policies and procedures regarding the use of Tredyffrin Township Public Access TV facilities and equipment, and agree to abide by them.
- B. I assume full responsibility (shared with my Sponsor) for the content of all material produced, created and included in the program, and ensure that such program material will not violate the rights of any third party.
- C. I attest that I will obtain—before the program is cablecast—all approvals, clearances, licenses, etc. for the use of any program material which I cablecast, including but not limited to: approvals by broadcast stations, networks, sponsors, music licensing organizations, copyright owners, performers' representatives, all persons appearing in the program material, and any other approvals that may be necessary to transmit programming over the Comcast channels.
- D. I agree to pay the costs to clean, repair or replace any Public Access equipment or property that is damaged, misused, lost or stolen while such equipment and property is in my or my crew's possession or control. I understand the penalties that apply if I do not return equipment or materials on time.
- E. I attest that only PA2-certified crewmembers will handle Tredyffrin Township Public Access TV equipment, and that the required number of PA2-certified crewmembers will staff each production.
- F. I agree to indemnify and hold harmless Comcast Cable, Tredyffrin Township, Tredyffrin Township Public Access TV, and their agents, employees and representatives from any and all liability and injury (including reasonable attorney's fees and costs incurred in defending claims) arising from, or in connection with: claims of failure to comply with any applicable laws, rules, regulations or other requirements of Tredyffrin Township Public Access and all local, state or federal authorities; claims of libel, slander, invasion of privacy, or the infringement of common law or statutory copyright; and claims of unauthorized use of any trademark, trade name or service mark. I understand that I may be criminally or civilly liable for producing or presenting such material for transmission.
- G. I will not represent to others that I am an employee, representative or agent of Comcast Cable, Tredyffrin Township (unless such is the case), or Tredyffrin Township Public Access TV; nor will I make such representations on behalf of any other person involved with this program.

- H. I agree my use of Tredyffrin Township Public Access TV facilities and equipment is for the purpose of creating television programming to be cablecast on the Comcast PEG channels and will not be produced for commercial gain for myself, crewmembers, talent, guests, or affiliates; or for any paid or bartered benefit of money, goods or services; or for personal use; or for the production of programming made in part at other television studios unless pre-approved in writing by the studio/station manager.

- I. I attest that talent and guests, and their employers, organizations, or affiliates will not pay for show appearances or for the dissemination of information; and that I will not pay myself, crewmembers, talent, or guests, or any affiliates thereof, for the production and cablecast/broadcast/online-streaming or any transmission or sale of programs produced, in whole or part, using Tredyffrin Township Public Access TV facilities and equipment.

- J. I understand that false or misleading statements or omissions made in this application are grounds for forfeiture of the privilege to use Tredyffrin Township Public Access production equipment, all facilities, and transmission over the Comcast PEG channels, and I will hold Comcast Cable, Tredyffrin Township, and Tredyffrin Township Public Access TV harmless against any loss or claim which results from any false or misleading statements or omissions.

- K. I understand that my use of Tredyffrin Township Public Access TV equipment and facilities is contingent upon the sponsorship of a Tredyffrin resident who must share full responsibility for all aspects of production and airing of my programming and who must also sign forms of indemnification and compliance.

- L. I agree that no oral modification, amendment, extension or waiver of this agreement will be binding upon me or Comcast Cable, Tredyffrin Township or Tredyffrin Township Public Access TV.
