# Annual Sponsor Statement of Compliance Form

I am thoroughly familiar with the rules, policies and procedures regarding commercialization, content restrictions, program responsibility, program standards, and all policies concerning out-of-house programming, and agree to abide by them.
- B. I attest that I am a legal resident of Tredyffrin Township.
- C. I assume full responsibility for the content of all material produced, created and included in the program, and ensure that such program material will not violate the rights of any third party.
- D. I attest that the Sponsored Producer has obtained—before the program is cablecast—all approvals (including that of the program’s producer[s]), clearances, licenses, etc. for the airing of the program and the use of any program material cablecast, including but not limited to: approvals by broadcast stations, networks, sponsors, music licensing organizations, copyright owners, performers’ representatives, all persons appearing in the program material, and any other approvals that may be necessary to transmit programming over the Comcast channels.
- E. I agree to indemnify and hold harmless Comcast Cable, Tredyffrin Township, Tredyffrin Township Public Access TV, and their agents, employees and representatives from any and all liability and injury (including reasonable attorney’s fees and costs incurred in defending claims) arising from, or in connection with: claims of failure to comply with any applicable laws, rules, regulations or other requirements of Tredyffrin Township Public Access and all local, state or federal authorities; claims of libel, slander, invasion of privacy, or the infringement of common law or statutory copyright; and claims of unauthorized use of any trademark, trade name or service mark. I understand that I may be criminally or civilly liable for producing or presenting such material for transmission.
- F. I will not represent, and have not represented, to others that I am an employee, representative or agent of Comcast Cable, Tredyffrin Township, or Tredyffrin Township Public Access TV; nor will I make (nor have I made) such representations on behalf of any other person involved with this program.
- G. I agree that this program does not result in commercial gain for myself, the program’s producer(s), crewmembers, guests, and/or affiliates; or in any other commercial benefits for any party involved in any way.

- H. I attest that talent and guests, and their employers, organizations, or affiliates are not paid (in money, goods, or services) for show appearances or for the dissemination of information; and that neither myself, the program's producer(s), crewmembers, talent, or guests, or any affiliates thereof, are paid in money, goods, or services for the show's production and/or cablecasting/transmission on Comcast Cable PEG channels or any other channels, or any other medium, including the Internet.

I understand that false or misleading statements or omissions made in this application are grounds for forfeiture to air this series/program on Comcast Cable PEG channels, and I will hold Comcast Cable, Tredyffrin Township, and Tredyffrin Township Public Access TV harmless against any loss or claim which results from any false or misleading statements or omissions.
- J. I agree that no oral modification, amendment, extension or waiver of this agreement will be binding upon me or Comcast Cable, Tredyffrin Township or Tredyffrin Township Public Access TV.
