Ordinance No. HR-431

AN ORDINANCE AMENDING CHAPTER 195, VEHICLES AND TRAFFIC, OF THE CODE OF ORDINANCES OF TREDYFFRIN TOWNSHIP, INCLUDING ADDITIONS TO THE SCHEDULES LISTING STREETS WITH STOP INTERSECTIONS AND PARKING PROHIBITIONS.

AND NOW, this ____ day of October, 2019, the Board of Supervisors of Tredyffrin Township hereby **ENACTS** and **ORDAINS** as follows:

Section 1. Article IX, Schedules, §195-58, Schedule IX: Stop Intersections, incorporated by reference in Article II, Traffic Regulations, §195-15, Stop intersections, of the Vehicle and Traffic Code, Chapter 195 of the Code of Ordinances of Tredyffrin Township is hereby amended to designate additional intersections as stop intersections and authorize the installation of stop signs at the following locations:

Stop Sign on	Direction of Travel	At intersection of
Catalpa Drive	South	Pineview Drive
Stephens Drive	East	Weedon Road
Vassar Road	North	Radcliffe Road
Vassar Circle	East	Vassar Road
Lawrence Lane	West	Vassar Road
Lawrence Lane	East	Vassar Road

Section 2. Article IX, Schedules, §195-63, Schedule XIV: Parking Prohibited at All Times, incorporated by reference in Article III, Parking Regulations, §195-21, Parking prohibited at all times, of the Vehicle and Traffic Code, Chapter 195 of the Code of Ordinances of Tredyffrin Township is hereby amended to prohibit parking and to authorize the installation of “No Parking” signs at the following locations:

Name of Street	Side	Location
South Valley Road	West	Lancaster Avenue to a point 150 feet south thereof

Section 3. Applicability. The provisions hereof shall supersede any ordinances or parts of ordinances which are inconsistent herewith.

Section 4. Severability. If any provision, sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Board of Supervisors that this

Ordinance would have been adopted had such unconstitutional, illegal or invalid provision, sentence, clause, section or part thereof not been included herein.

Section 5. Effective Date. This Ordinance shall take effect and be in full force and effect thirty-one (31) days from enactment.
