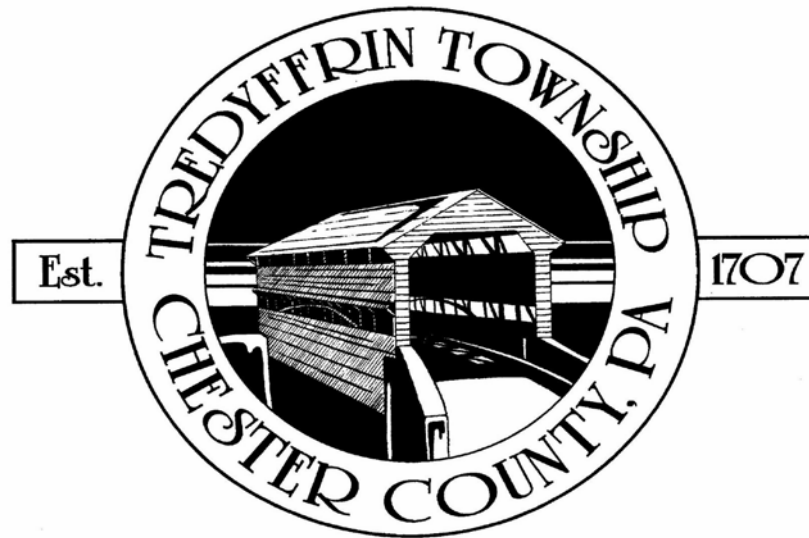

SYNOPSIS

It gives me great pleasure to provide this synopsis of the Tredyffrin Township Police Department's annual report of the activities for the calendar year 2004. As you may know, crime is classified, counted, and reported in two distinctly separate categories. These categories are known by statisticians and researchers as Part I crimes and Part II crimes, respectively. Part I crimes consists of those crimes that one may consider to be the most serious crimes affecting society. Part I crime is comprised of a very specific subset of crimes that are reported to the Federal Bureau of Investigation, through the Pennsylvania State Police, for comparison nationwide with crime reported by other law enforcement agencies of similar size and demographics. Part II crimes, on the other hand, are defined as any crime specifically excluded from the subset of crimes known as Part I crime. By their very nature, Part II crimes are generally considered to be less serious, including nuisance crimes, tending to impact the quality of life of only those specifically affected by the actual occurrence of an individual crime.

Overall, reported crime in Tredyffrin Township increased 10% during calendar year 2004 with a total of 1,893 crimes reported to the Tredyffrin Township Police Department. Part I crimes, the more serious category of crime, increased a total of 7% and Part II crimes increased 11%, for an aggregate increase of 10%.

Although no one wants to see increases in crime, the fact of the matter is that the 10% increase in crime reported this year is nothing more than an "adjustment" due to a combination of two factors:

- A history of alternating double digit increases and decreases in crime during the past four years; and
- A decrease in calls-for-service resulting in more time available for patrol and investigative activities resulting in increased numbers of on-view and investigative arrests.

Part I crimes consists of a very specific subset of crime that includes murder, rape, robbery, assault, burglary, arson, theft and motor vehicle theft. Part I crimes increased 7% during calendar year 2004 from 394 such crimes reported during 2003 to 423 reported during 2004.

However, the current figure is actually 6% lower than the average for this category during the three previous reporting years (2001-2003), 15% lower than during calendar year 2001, and 8% lower than reported during 2002.

The import of the Part I crime statistic is quite significant to our many and varied constituencies. For example, some of the increase is due largely to the fact that calls-for-service were down 6% this year giving the agency more patrol and investigative time. This, in turn, resulted in a 32% increase in criminal arrests and an artificial inflation in the category known as Part I crime. This is also an important statistic for those individuals considering moving their family or business into Tredyffrin Township as it can be compared nationwide against other municipalities of similar size and demographics. It is also a statistic that is easily accessible by those seeking such information in their decision-making process.

Part II crime is a category consisting of all crime other than those specifically included in the Part I category. By their very nature, Part II crimes are generally considered to be less serious, including nuisance type crimes, tending to impact the quality of life of only those specifically affected by the actual occurrence of an individual crime. During calendar year 2004, Part II crimes increased 11%. Again, the increase can be attributed to the two factors cited above.

Other statistics of general interest to the citizens and businesspersons of Tredyffrin Township include:

I am pleased to report that there was a 26% decrease in the overall economic loss associated with crime. This is in addition to the 21% decrease in the economic loss due to crime reported during calendar year 2003.

During the past calendar year, victims of crime in Tredyffrin Township lost \$385,291 due to crime. This figure actually represents \$136,830 fewer dollars lost this year than as compared to the economic loss incurred during 2003. Furthermore, this year's figure is considerably lower than the loss of \$659,563 reported during 2002.

During 2004, traffic crashes increased 2% in Tredyffrin Township with the following sub-categories of traffic crashes changing as indicated:

Fatal Crashes	200% (from 1 to 3)
	2 involved alcohol
	1 involved speed on snow covered roadway
	all 3 involved lack of proper passenger restraint
Reportable Crashes	4% (from 296 to 309)
Non-Reportable Crashes	1% (from 766 to 778)
Deer Related Crashes	-2% (from 134 to 131)

Although deer related crashes have remained relatively constant during the past three years, 131 to 135 crashes during each of the past three years, this should not be seen as either a victory or a turning point with respect to accidents involving deer. The actual number of accidents involving deer is as high today as it was in 1996 when the Board of Supervisors took the courageous step to authorize deer hunting in Township parks by a professional archery association. Without this courageous step taken by the Board of Supervisors, it is clear that the total number of accidents involving deer today would be far greater than reported in this annual report.

Traffic arrests increased 8% during 2004 with a total of 7,625 traffic summonses being issued. Furthermore, the Traffic Safety Unit increased production by 23% during the past year and has realized a 182% increase in production during the past three years.

The Tredyffrin Township Police Department places a high emphasis on searching for DUI drivers in an attempt to lower the number of fatalities in the Township and lessen the personal injury and economic loss associated with traffic crashes. During 2004, 187 DUI arrests were made in the Township. That is a 25% increase over the number of DUI's arrested during 2003.

It is with pride and pleasure that I present this synopsis of the Tredyffrin Township Police Department's Annual Report for the calendar year 2004. It is my sincere desire that this synopsis is both informative to you and useful to the various constituencies we are sworn to protect and serve.

GENERAL STATISTICS

2004

Overall, reported crime in Tredyffrin Township increased 10% during calendar year 2004 with a total of 1,893 crimes reported to the Tredyffrin Township Police Department. Part I crimes, the more serious category of crime, increased a total of 7% and Part II crimes increased 11%, for an aggregate increase of 10%.

Although no one wants to see increases in crime, the fact of the matter is that the 10% increase in crime reported this year is nothing more than an “adjustment” due to a combination of two factors:

- A history of alternating double digit increases and decreases in crime during the past four years; and
- A decrease in calls-for-service resulting in more time available for patrol and investigative activities resulting in increased numbers of on-view and investigative arrests.

Part I crimes consists of a very specific subset of crime that includes murder, rape, robbery, assault, burglary, arson, theft and motor vehicle theft. Part I crimes increased 7% during calendar year 2004 from 394 such crimes reported during 2003 to 423 reported during 2004. However, the current figure is actually 6% lower than the average for this category during the three previous reporting years (2001-2003), 15% lower than during calendar year 2001, and 8% lower than reported during 2002.

The import of the Part I crime statistic is quite significant to our many and varied constituencies. For example, some of the increase is due largely to the fact that calls-for-service were down 6% this year giving the agency more patrol and investigative time. This, in turn, resulted in a 32% increase in criminal arrests and an artificial inflation in the category known as Part I crime. This is also an important statistic for those individuals considering moving their family or business into Tredyffrin Township as it can be compared nationwide against other municipalities of similar size and demographics. It is also a statistic that is easily accessible by those seeking such information in their decision-making process.

Part II crime is a category consisting of all crime other than those specifically included in the Part I category. By their very nature, Part II crimes are generally considered to be less serious, including nuisance type crimes, tending to impact the quality of life of only those specifically affected by the actual occurrence of an individual crime. During calendar year 2004, Part II crimes increased 11%. Again, the increase can be attributed to the two factors cited above.

Other statistics of general interest to the citizens and businesspersons of Tredyffrin Township include:

I am pleased to report that there was a 26% decrease in the overall economic loss associated with crime. This is in addition to the 21% decrease in the economic loss due to crime reported during calendar year 2003.

During the past calendar year, victims of crime in Tredyffrin Township lost \$385,291 due to crime. This figure actually represents \$136,830 fewer dollars lost this year than as compared to the economic loss incurred during 2003. Furthermore, this year's figure is considerably lower than the loss of \$659,563 reported during 2002.

During 2004, traffic crashes increased 2% in Tredyffrin Township with the following sub-categories of traffic crashes changing as indicated:

Although deer related crashes have remained relatively constant during the past three years, 131 to 135 crashes during each of the past three years, this should not be seen as either a victory or a turning point with respect to accidents involving deer. The actual number of accidents involving deer is as high today as it was in 1996 when the Board of Supervisors took the courageous step to authorized deer hunting in Township parks by a professional archery association. Without this courageous step taken by the Board of Supervisors, it is clear that the total number of accidents involving deer today would be far greater than reported in this annual report.

Traffic arrests increased 8% during 2004 with a total of 7,625 traffic summonses being issued. Furthermore, the Traffic Safety Unit increased production by 23% in addition to the 129% increase it realized during the previous calendar year.

The Tredyffrin Township Police Department places a high emphasis on searching for DUI drivers in an attempt to lower the number of fatalities in the Township and lessen the personal injury and economic loss associated with traffic crashes. During 2004, 187 DUI arrests were made in the Township. That is a 25% increase over the number of persons arrested for driving under the influence during 2003.

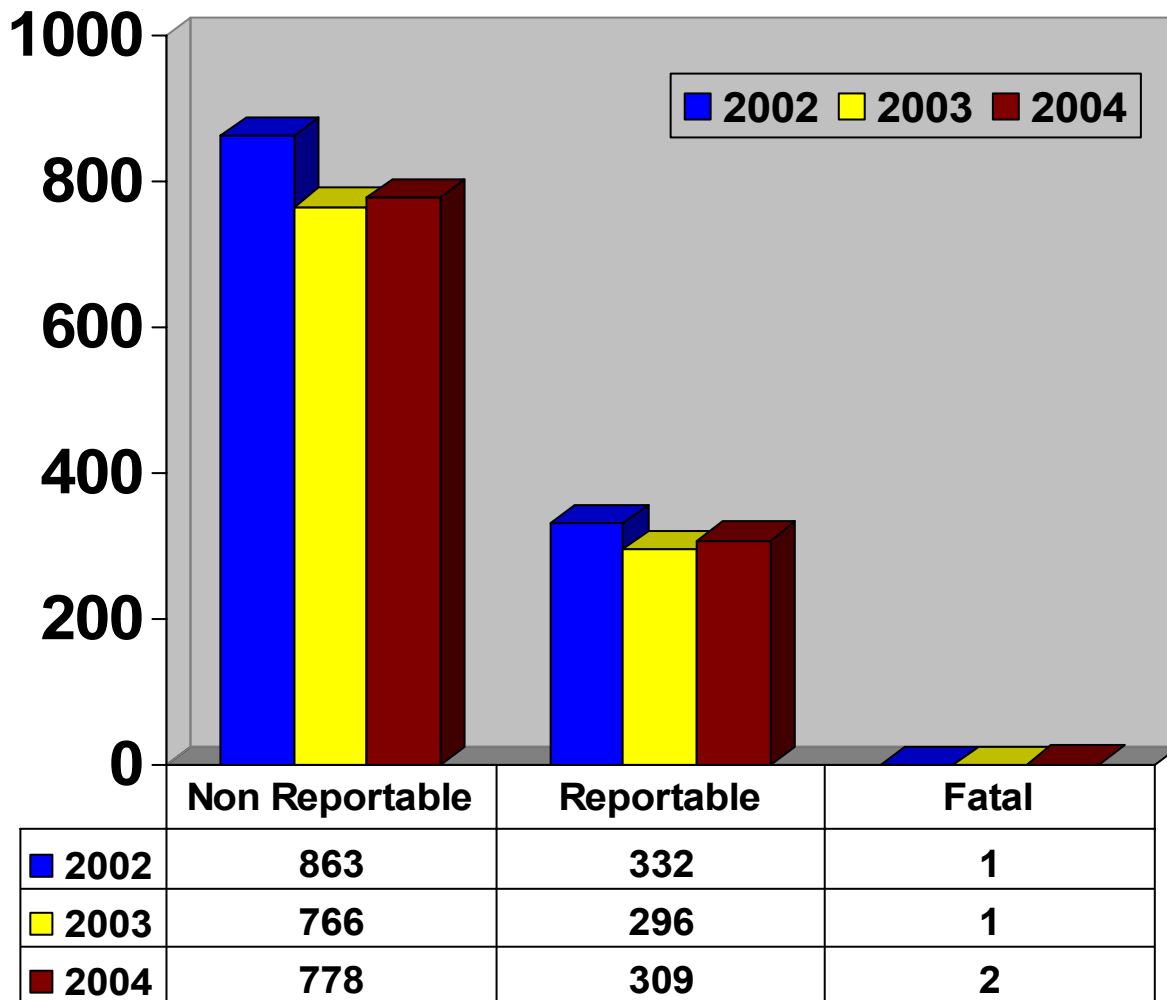

ACCIDENT ANALYSIS

Overall, vehicle crashes in Tredyffrin Township increased 2.5% from 2003 to 2004, with 27 more crashes. A 2.5% increase is not statistically significant given the fact the Tredyffrin Township Police Department investigates nearly 1100 vehicle crashes per year.

Motor vehicle accidents, more particularly and more accurately described as “motor vehicle crashes,” are divided into three distinctive categories for reporting purposes and analysis:

1. Reportable Crashes
2. Non-Reportable Crashes
3. Fatalities

In Tredyffrin Township, it is also important to add a fourth category of vehicle crash for reporting purposes:

4. Deer related motor vehicle crashes

REPORTABLE CRASHES:

Reportable crashes are defined as those crashes in which the driver, vehicle occupant, pedestrian, or bicyclist is injured, or the damage to the vehicle is so severe as to render it inoperable. During calendar year 2004, Tredyffrin Township Police Department investigated 309 reportable crashes, up 4% from the previous year.

NON-REPORTABLE CRASHES:

Non-reportable crashes are defined as the converse of reportable crashes. Said another way, non-reportable crashes are defined as those motor vehicle crashes in which no one is injured and the vehicle remains operatable under its own power. Although commonwealth law does not require one to report this category of motor vehicle crash to the police, the Tredyffrin Township Police Department will investigate, document, determine causation, and issue citations when called to the scene by parties involved in the crash. As such, the Tredyffrin Township Police Department has a more accurate picture of all crashes occurring in the township, although this picture is more accurate than if the police department did not

investigate this category of crash, there is no way to determine how many crashes occur in which the parties settle between themselves or what percentage of crashes in this category are actually reported to the police department.

The total number of non-reportable crashes reported to the police department during 2004 equal 778, up 1.6% from 2003

DEER RELATED CRASHES:

During 2004, there were 131 motor vehicle crashes involving deer in Tredyffrin Township. That figure represents a 2% decrease from 2003 when there were 134 deer related crashes. However, in economic terms, deer related motor vehicle crashes totaled more than \$130,000 in property damage to drivers in Tredyffrin Township (using a \$1,000 average damage estimate per collision.).

FATAL CRASHES:

There were two traffic crashes in Tredyffrin Township during calendar year 2004 resulting in a total of three fatalities. This is compared to one crash during 2003 which resulted in one fatality. The following is a brief synopsis of each crash during 2004 resulting in a fatality:

January 15, 2004

A Wilmington, Delaware, resident traveling north bound on Route 202 lost control of her vehicle on the snow covered roadway, crossed the grass median, and was broadsided by oncoming traffic. The cause of the crash, as well as the driver's death, was attributed to the following factors:

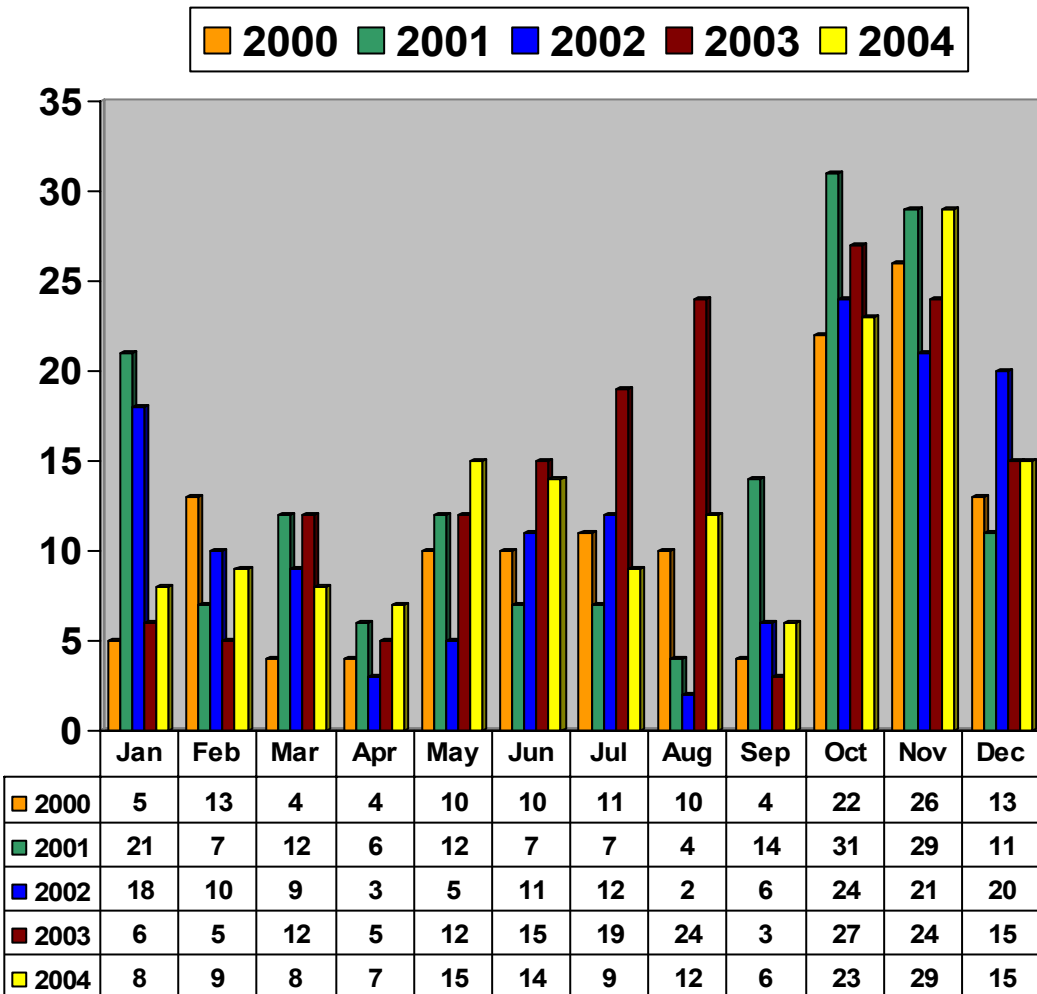
1. Excessive speed on a snow covered roadway; and
2. Improper use of occupant safety restraints.

July 23, 2004

Two occupants of one vehicle, one a resident of the Norristown area and the other a resident of the Downingtown area, traveling southbound on Church Road collided head-on with a vehicle traveling northbound on the same roadway. The cause of the crash, as well as the deaths of both occupants of the southbound vehicle, was attributed to the following factors:

1. Driving while intoxicated;
2. Speeding; and
3. Lack of use of vehicle occupant safety restraints.

DEER RELATED INCIDENTS

Deer related incidents, defined as all incidents involving deer, decreased 7% between 2003 and 2004. In raw figures, that equates to a decrease of 12 incidents from 167 during 2003 to 155 during 2004. By far, the vast majority of reported deer related incidents in Tredyffrin Township involve motor vehicle crashes; of the 155 total deer related incidents, 131 or 85%, involved motor vehicle crashes.

Viewed in dollars and cents, if one considers \$1,000 to be the average cost to repair a vehicle after a deer crash, and I suggest that \$1,000 is a low but very real estimate, then residents and visitors of Tredyffrin Township suffered over \$130,000 in property loss due to deer related crashes during the calendar year 2004. During the past three years, residents and visitors of Tredyffrin Township suffered a loss of \$400,000 due to deer crashes and a loss of approximately \$1.4 million over the past ten years.

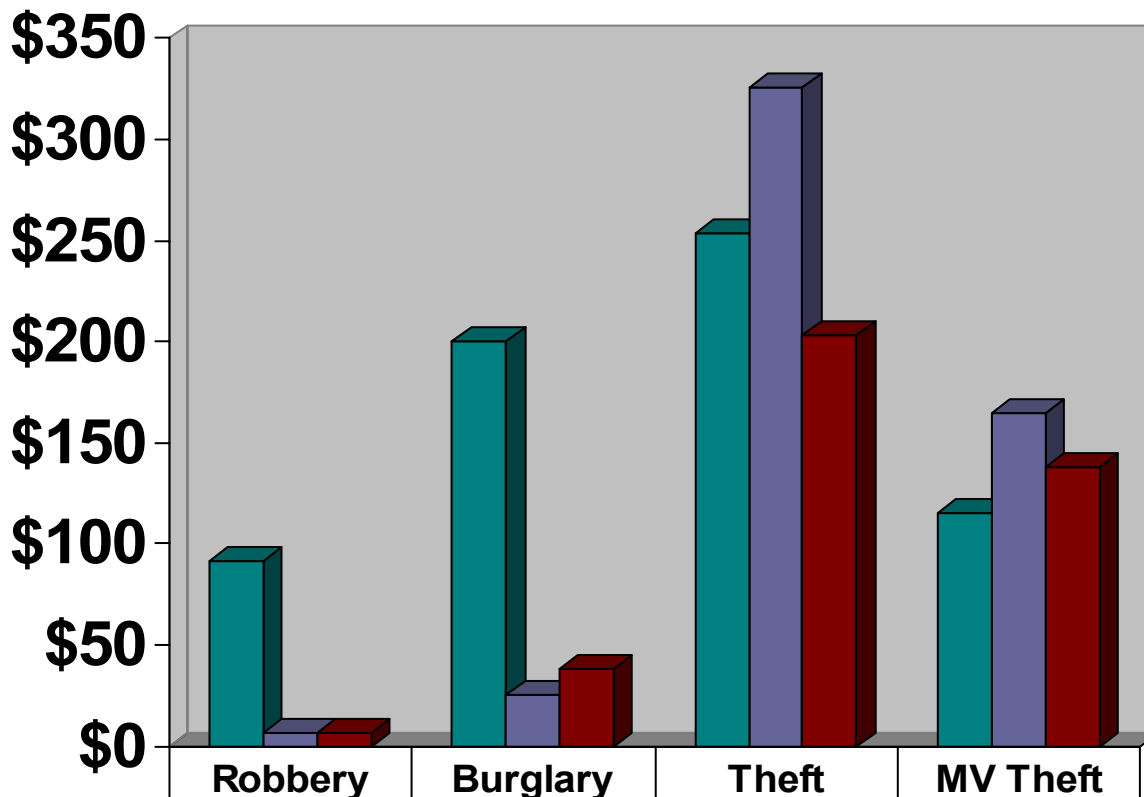
Although deer related traffic crashes decreased 2% from 2003 to 2004, this should not be seen as either a victory or a turning point with respect to vehicle crashes involving deer. The actual number of accidents during 2004 was as high as in 1996 when the Board of Supervisors first decided to authorize hunting in Township parks by a professional archery association. Without this courageous step taken by the Board of Supervisors it is clear that accidents involving deer today would be far greater than current levels. Therefore, it is suggested that any and all efforts to kill the deer herd in Tredyffrin Township be continued and further encouraged to lessen the property loss and/or cost associated with deer crashes.

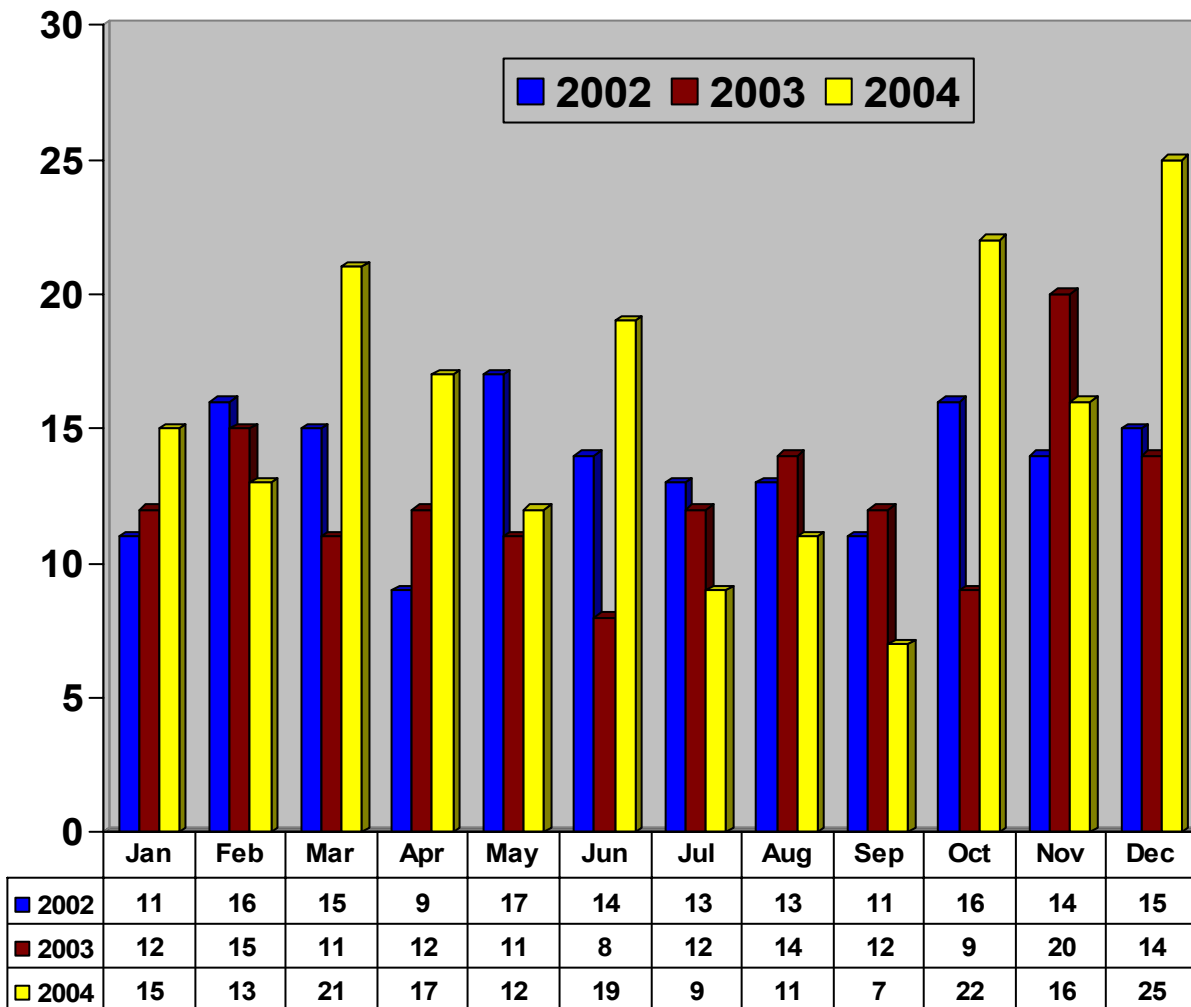
PROPERTY LOSS

Crime related property loss to residents and visitors of Tredyffrin Township decreased 26% during calendar year 2004 from \$522,000 to \$385,000 a reduction of approximately \$137,000. During the three year period from 2002 to 2004, residents and visitors of Tredyffrin Township realized a 41% decrease in property loss due to crime from \$660,000 to \$385,000.

Percent Change: 2002 -23%, 2003 -9% and 2004 +25%

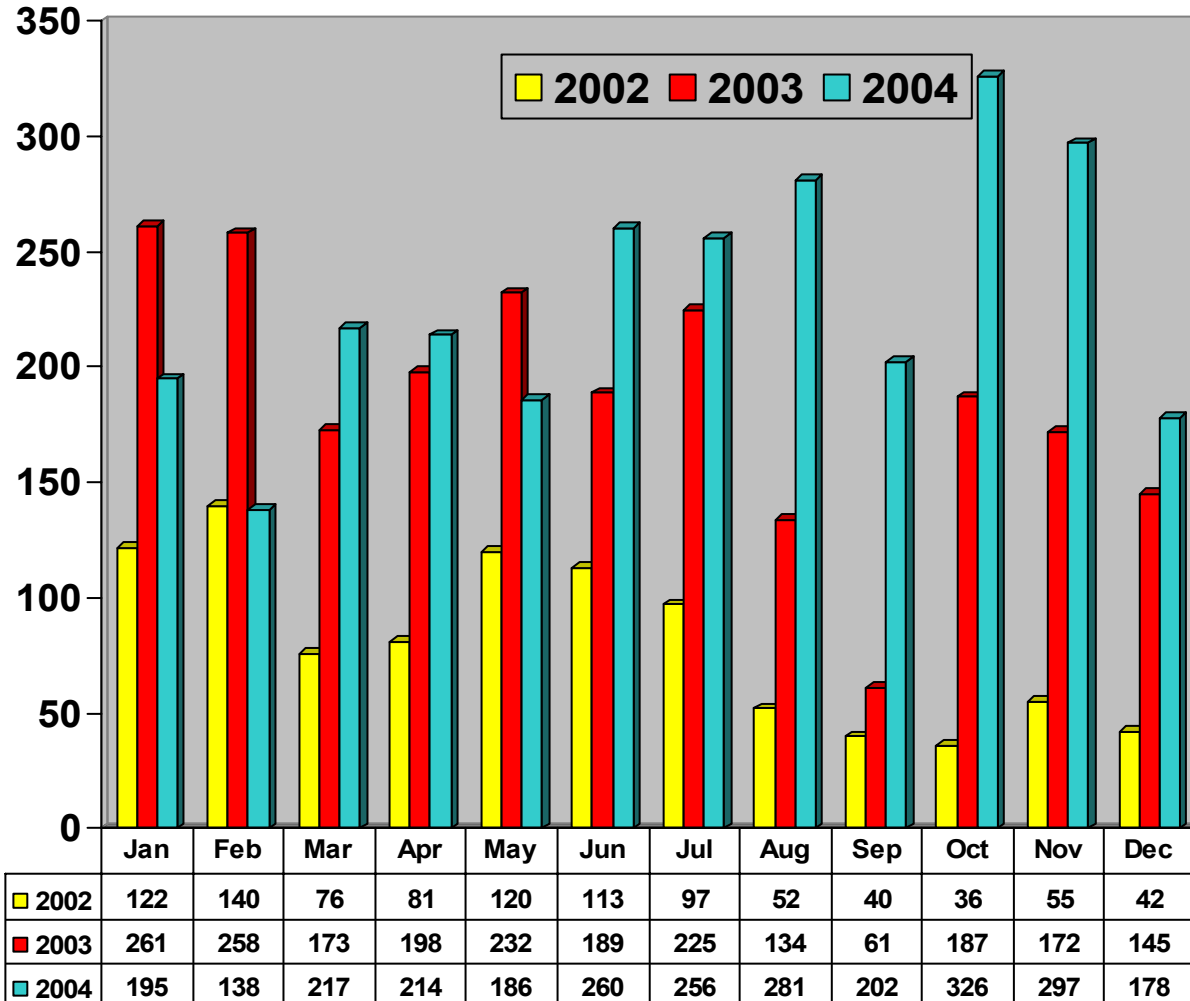

DRIVING UNDER THE INFLUENCE

The Tredyffrin Township Police Department places high emphasis on searching for DUI drivers in an attempt to lower fatalities in the township due to alcohol and/or drug related vehicle crashes and to lessen the overall personal injury and property loss due to vehicle crashes. During the calendar year 2003, the police department arrested 150 individuals for Driving under the Influence of Alcohol or Drugs. That was the highest of any Chester County law enforcement agency and an achievement for which the police department won an award from the Mothers against Drunk Driving (MADD) organization.

During the calendar year 2004, Tredyffrin Township Police Department realized a 25% increase in DUI arrests as compared to 2003 with a total of 187 arrests. Taking this increase into consideration, I fully expect Tredyffrin Township Police Department will once again be the recipient of an award from the MADD organization as the highest achieving and most aggressive law enforcement agency in the removal of intoxicated drivers from the roadways of Chester County.

Tredyffrin Township Police Department Traffic Squad Citations / Warnings Issued



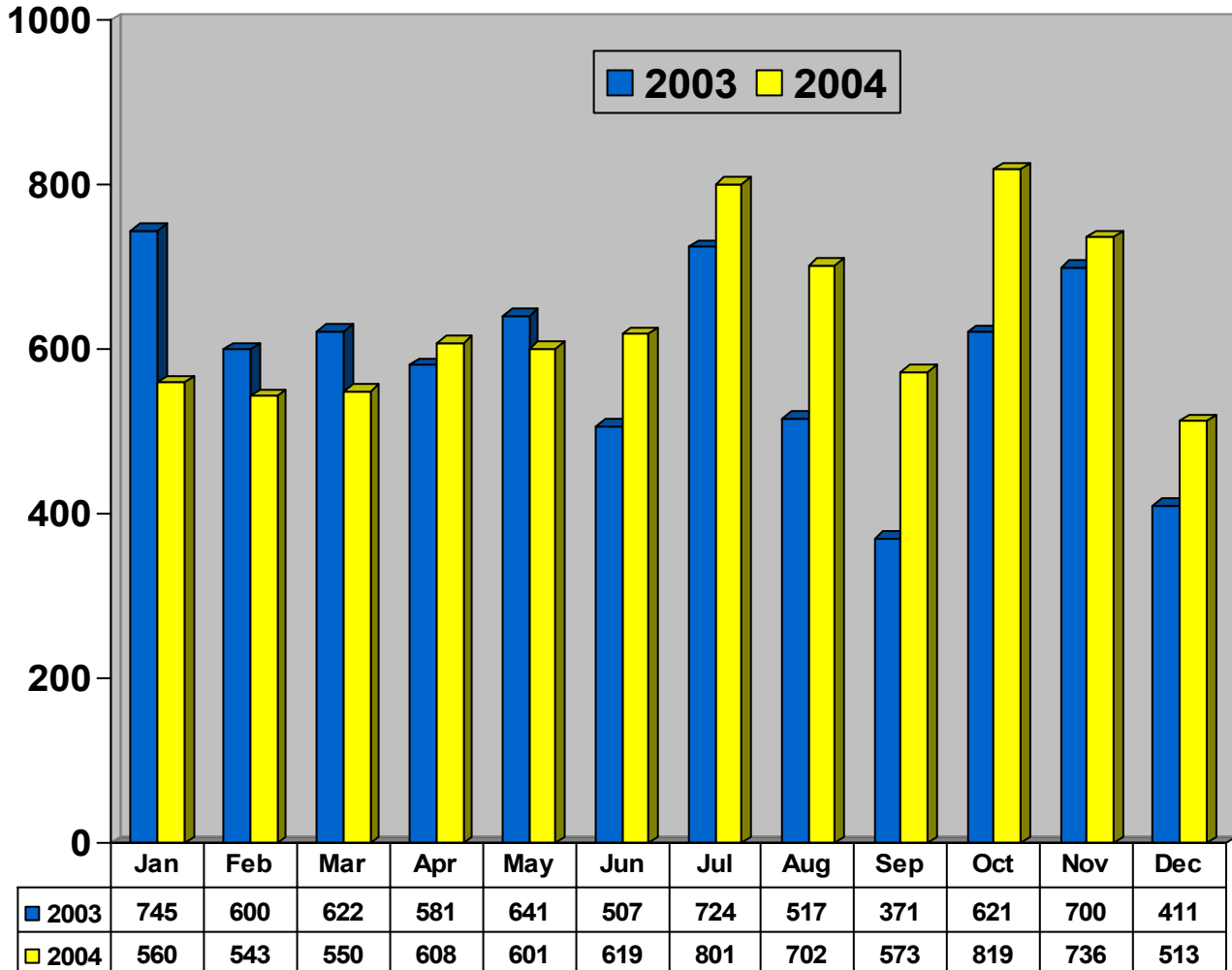

TRAFFIC SAFETY UNIT STATISTICS

Specific emphasis was placed on the productivity of the Traffic Safety Unit during 2004 with high expectations for specific results. I am proud to report that the Traffic Safety Unit realized a 23% increase in productivity during 2004. The unit's work output rose from 2235 citation/warnings during 2003 to 2750 citation/warnings during 2004. Additionally, the Traffic Safety Unit's production has increased a total of 182% since an emphasis was placed on the unit's goals and objectives in early 2003.

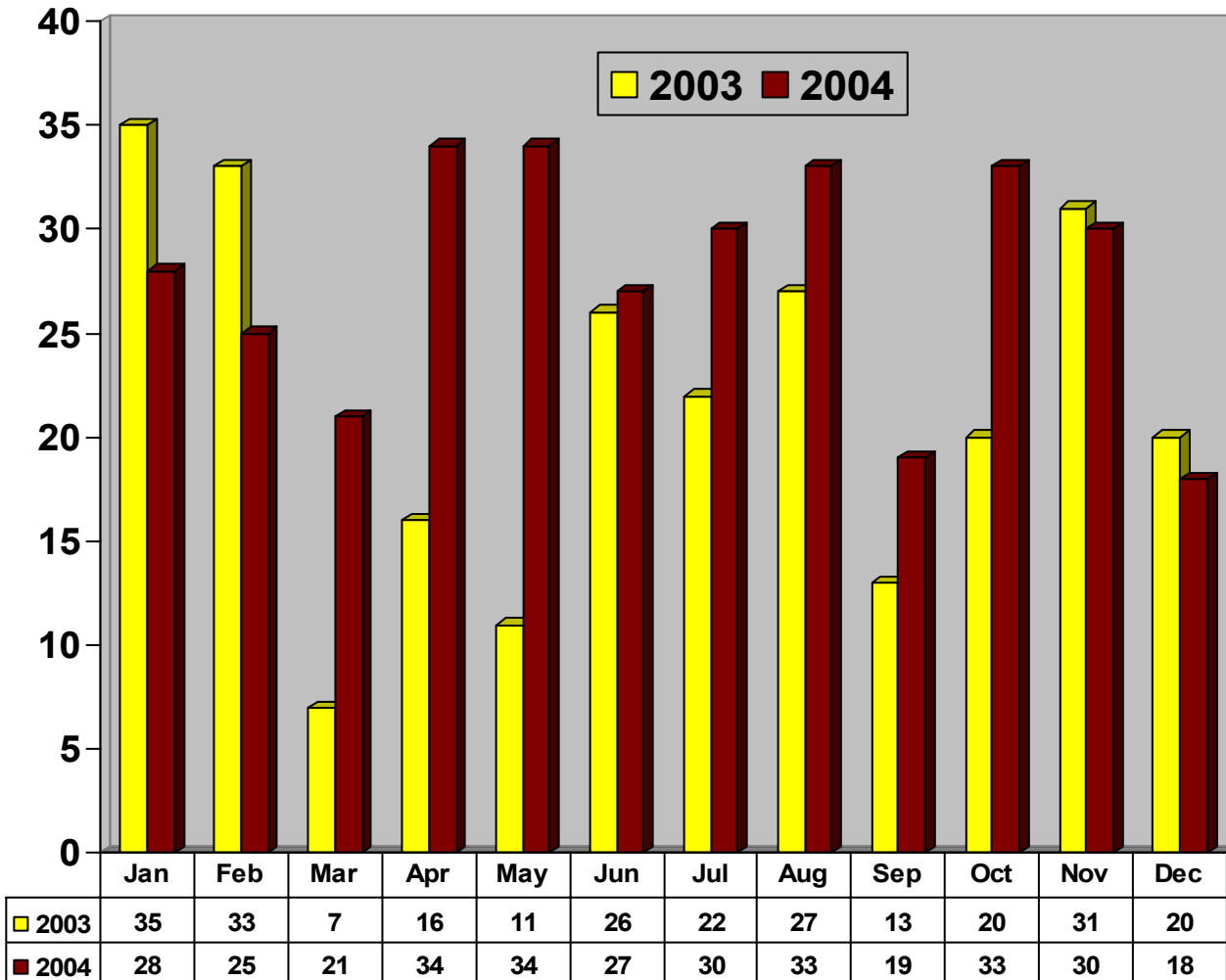
TRAFFIC ARRESTS

During calendar year 2004, Tredyffrin Township Police Department issued 7,625 traffic citations, an 8% increase over calendar year 2003 and a 35% increase over calendar year 2002. Special emphasis has been placed on two very specific areas to ensure that traffic enforcement realizes the biggest benefit based on the resources allocated. These two areas include:

1. Top 10 accident producing intersections; and
2. Top 10 complaint producing roadways.

The police department alternately places a traffic enforcement emphasis on these two areas in an effort to reduce accidents and complaints of speeding in the township.

NON-TRAFFIC CITATIONS

The non-traffic citation is the official name in Pennsylvania for the issuance of a criminal summons for violation of a summary criminal offense, the lowest of all criminal offenses in the Commonwealth. More specifically, it is similar to a traffic ticket in that a police officer may stop an individual and issue a summons on a minor criminal offense, such as a quality of life violation, or mail the summons to the offender's residence at a later date.

During 2004 Tredyffrin Township Police Department issued 332 such criminal summonses for minor quality of life violations, such as disorderly conduct and similar offenses. This represents a 27% increase in the issuance of summonses during 2004 and a 32% increase since 2002.

PERSONNEL ASSIGNMENTS

There are currently 60 individuals employed by Tredyffrin Township assigned to the police department. Of those, 51 are sworn personnel (police officers) and 9 are staff support (non-sworn personnel). With respect to the sworn personnel, 82% are assigned to the Patrol function to respond to 911 calls-for-service. Of the remaining 18%, 10% are assigned to the Criminal Investigative function where they initiate criminal investigations and conduct follow-up investigations for those assigned to the Patrol function to allow those officers additional time to perform proactive patrols. The remaining 8% are the administrative staff in the police department, including the Superintendent, Captain and two Lieutenants, all of whom, from time to time, respond to 911 calls-for-service and serious incidents to provide assistance to those assigned to the Patrol function.

The following is a statistical analysis of personnel assignments in the police department:
