FLOOD STUDY - ESCROW AMOUNT

Flood Study Review

\$3,500 initial deposit; \$1,000 minimum balance

Flood Study Reviews: This shall be required and will be funded by the applicant in the initial amount of \$3,500. This will cover fees for engineering reviews, inspections, agreements if necessary, legal reviews, and other communications, and will be billed per the fees generated by the Township Consultants, and reimbursed by the applicant funded account. The applicant is required to pay all cost overages; upon the balance of the account reaching \$1,000, the applicant will be required to deposit appropriate funds sufficient to keep a balance of \$3,500. All unused funds will be returned to the applicant upon completion of the project.
